With reference to the first citation, the Multi State Cooperative Election Authority has ordered the conduct of the Board of Directors and Office Bearers election to the ONGC Employees Cooperative Thrift & Credit Society Ltd., and appointed the District Collector of Chennai as the Returning Officer.

In the second reference cited, the election programme issued by the Cooperative Election Authority was communicated through newspaper publication to the members of the Society located in Tamil Nadu, Karaikal of Puducherry, Rajahmundry and Kakinada Districts of Andhra Pradesh. As per the notified election schedule, the polling date has been fixed on 12.07.2026(Sunday).

Meanwhile, in the third reference cited, the General Secretary of the Petroleum Employees Union has represented to the Returning Officer that the polling date, namely 12.07.2026, falls on a Sunday, which is a holiday for ONGC offices. This may result in a poor voter turnout.

Further, a large number of members are working under a 14 days ON/OFF duty pattern, and their work locations are spread over a radius of nearly 200 kilometres from the Base Office. Many members are residing in different States across the country, making it difficult for them to cast their votes on a single day. It has also been stated that in previous elections, polling was conducted on two different dates for the convenience of members.(Copy of the Previous election schedule is enclosed for reference)

Hence, the Union General Secretary has requested that the polling date may kindly be changed from Sunday to a working day of ONGC and that an additional polling date may also be provided for the polling centres, as was followed in earlier elections. (Copy enclosed)

In view of the above, I kindly request the Cooperative Election Authority to consider the request of the Petroleum Employees Union and permit the conduct of the Board of Directors election on two different dates for the convenience of the members. The polling dates and subsequent election schedule of ONGC Employees Cooperative Thrift and Credit Society Ltd., may accordingly be revised suitably.

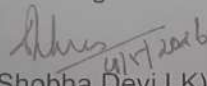

Rajahmundry and Karaikal Thrift society Board Elections- 2026.

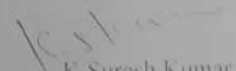
Respected Madam,
